1. Purpose of Conference

Both undergraduate and graduate students must be members to give technical or poster sessions. Non-member students can participate in technical and poster sessions with the authorization of the relevant board of administration. Young professional engineers can participate in technical and poster sessions with the approval of the organizer.

Creation of paper drafts in accordance with JSAE speaker regulations / speaker information, speaker regulations 3 on A4 paper (portrait, double column, 2 - 4 pages).
